2016 was a great year for the CCMH Foundation. Please accept our deep gratitude for your support of Community Memorial Hospital and Sunnyside Health Care Center this past year.

CCMH Foundation gives \$197,000 in equipment and updates

Over \$192,000 was recently given to the Surgery Department to purchase state-of-the-art mobile arthroscopic surgical equipment, allowing more surgical suites to be used simultaneously for arthroscopic surgery. Over \$4,000 of the donation was used to provide badge reading equipment for the Urgent Care/Emergency Services Department which allows only authorized personnel to enter restricted areas.

In the past, your gifts have purchased monitors, radios, power equipment for the Surgery Department, crash carts and cardiac rehab equipment. The CCMH Foundation supported the Diabetes Health Fair and provided equipment for our classrooms, a Caretracker System for Sunnyside and a phlebotomy chair for our lab. You have helped to fund our retrofits for the therapy departments and our new addition. And you helped to supply our staff with the equipment and tools they need to provide the very best care.
